**REGISTRATION
APPLICATION**

I hereby make application to register as a candidate for admission to the practice of law in Ohio. In conformity with Rule I of the Supreme Court Rules for the Government of the Bar, I am submitting the following:

- (1) an original certificate executed by the dean of the law school where I first began the study of law certifying **when** I first began the study of law;
- (2) an original, hard copy of my certified transcript of college credits evidencing that I earned a bachelor’s degree or a certificate from the dean of the law school I am attending, certifying that I am participating in a three-plus-three program;
- (3) two copies of an Applicant’s Character Questionnaire, single-sided;
- (4) original Acknowledgement of Complete Application form and one copy;
- (5) a fingerprint identification card;
- (6) two original, separately executed General Authorization and Release forms (7A);
- (7) one original, signed and dated NCBE Authorization and Release form (7D);
- (8) original Authorization to Release Medical Information (7B) and/or Authorization to Release Information (7C) (if I have answered “yes” to any applicable questions on my Questionnaire);
- (9) a non-refundable registration fee in the amount of \$75, by **certified check or money order** made payable to the Supreme Court of Ohio;
- (10) the Payment Confirmation Form from the National Conference of Bar Examiners (“NCBE”) and if applicable, a non-refundable fee by **check** made payable to the NCBE, in the appropriate amount as indicated on the NCBE fee schedule; and
- (11) an additional non-refundable late fee in the amount of \$200, by **certified check or money order** made payable to the Supreme Court of Ohio, if this Registration Application is not filed by November 15 of my second year of law school.
- (12) if applicable, and admitted and in good standing in another jurisdiction, a complete Application for Certification to Practice Pending Admission with the supporting documents.

I understand that my Registration Application will not be filed if it does not have the necessary documents attached; if it is not accompanied by the appropriate fee(s); if any portion of it is not properly executed; if any portion of it is missing; or if any questions are unanswered, incompletely answered, or missing any required details. I also understand that my application will not be filed until it is received in the Office of Bar Admissions.

I have read Rule I of the Supreme Court Rules for the Government of the Bar, which pertains to admission to the practice of law in Ohio. I understand that approval of my Registration Application is subject to the procedures in Rule I. I also understand that, before I may sit for an Ohio bar examination, I must file a **separate** Application to Take the Bar Examination by the filing deadline prescribed in Rule I and must be timely approved as to character, fitness, and moral qualifications to practice.
