



Important Notes:

- **Registration:** Registration **begins two months before** and ends when the event is full and **NOT required for virtual events.**
 - 1. Go to www.judicialedcademy.ohio.gov
 - 2. Select “**Login or create an account**” at the upper right corner of the page.
 - 3. To Login:
 - **Ohio Attorneys:** Login on the left side using your Ohio Attorney Registration Number (username) and Attorney Services password.
 - **Non-Attorneys:** Login on the left side or create an account.
 - *If you do not have a username and password, go to “New User? Register” and follow the instructions to create your own account. You will receive an email within 3 business days with your approval status.*
 - **Forgot your username or password?** Click the “**Forgot your username/password?**” link under the login box and follow the specific instructions for if you are an Ohio attorney or a non-attorney.
 - 4. Once logged in to Judicial eCademy, scroll to the search results window.

- 5. Select the course you wish to attend and click “**Register online**,” then follow the steps to complete your registration.
- 6. An email confirmation will be sent after you complete your registration.
