Important Notes:

- <u>Cancellations</u>: To inform us your cancellation, please contact us at least three business days before the event (preferably one week) that you have registered for. **Failure to do so results in costs incurred by the Court for which you may be charged for.**
- <u>Certificates of Completion</u>: For training required by the Rules of Superintendence for the Courts of Ohio, Rule 16. Mediation, participants will receive a certificate of completion if they are actively engaged for <u>ALL</u> of the required training hours under the Rule.
- <u>Registration</u>: Registration begins approximately two months before* and ends when the event is full and NOT required for virtual events.
 - 1. Go to <u>www.judicialecademy.ohio.gov</u>
 - 2. Select "Login or create an account" at the upper right corner of the page.
 - 3. To Login:
 - <u>Ohio Attorneys</u>: Login on the left side using your Ohio Attorney Registration Number (username) and Attorney Services password.
 - **<u>Non-Attorneys</u>**: Login on the left side or create an account.
 - If you do not have a username and password, go to "**New User? Register**" and follow the instructions to create your own account. You will receive an email within 3 business days with your approval status.

- <u>Forgot your username or password?</u> Click the "Forgot your username/password?" link under the login box and follow the specific instructions for if you are an Ohio attorney or a non-attorney.
- 4. Once logged in to Judicial eCademy, scroll to the search results window.
- 5. Select the course you wish to attend and click "**Register online**," then follow the steps to complete your registration.
- 6. An email confirmation will be sent after you complete your registration.
