Important Notes:

- **Cancellations:** To inform us your cancellation, please contact us at least three business days before the event (preferably one week) that you have registered for. **Failure to do so results in costs incurred by the Court for which you may be charged for.**
- **Certificates of Completion:** For training required by the Rules of Superintendence for the Courts of Ohio, Rule 16. Mediation, participants will receive a certificate of completion if they are actively engaged for **ALL** of the required training hours under the Rule.
- **Registration:** Registration **begins approximately two months before*** and ends when the event is full and **NOT required for virtual events.**

 - 2. Select “**Login or create an account**” at the upper right corner of the page.
 - 3. To Login:
 - **Ohio Attorneys:** Login on the left side using your Ohio Attorney Registration Number (username) and Attorney Services password.
 - **Non-Attorneys:** Login on the left side or create an account.
 - *If you do not have a username and password, go to “**New User? Register**” and follow the instructions to create your own account. You will receive an email within 3 business days with your approval status.*
