# HOPE COURT GIVES OFFENDERS AN ALTERNATIVE TO JAIL TIME

The Healthy Options Promoting Empowerment (HOPE) Behavioral Health Court, is a specialized program designed for non-felony offenders going through both Muskingum County Court and Zanesville Municipal Court. Presiding Judge Eric D. Martin said the program is designed for those who may not have committed a crime if it weren't for a mental illness or behavioral issue. He said The National Institute of Mental Health estimates the economic cost of untreated mental illness is \$300 billion each year and the Ohio Department of Rehabilitation and Correction reports that 27 percent of Ohio prisoners have mental health problems. <u>More...</u>

## INTERVENTION COURT BRILLIANT IDEA THAT WOULD BENEFIT ALL

A new program in Trumbull County Family Court will work to decrease alcohol and drug dependency and keep families intact. # FORT HAMILTON HOSPITAL SITE TO GET MENTAL HEALTH FACILITY

Fort Hamilton Hospital will soon be home to a 15-bed facility for people with severe mental illness.

The Butler County Mental Health Board recently allocated about \$420,000 to renovate a building located on the east side of the campus. Construction on the 5,500-square-foot facility, formerly a hospice unit called Vitas, began last month. It will house patients who aren't ready to live on their own, but aren't sick enough for hospitalization. <u>More...</u>

# CASES OF MURDER, SUICIDE UNLABELED

Headlines, police officers and grieving family members state the obvious: When one person kills another and then himself, it's a murder-suicide. But crime statistics fail to capture that reality. "We don't have a special category for it," said Columbus Police Division spokeswoman Amanda Ford. "It's not in the software." Columbus isn't unique. Most law-enforcement agencies don't compile official reports on murder-suicides because the federal Uniform Crime Reporting Program, to which agencies submit their local data, doesn't include murder-suicide as a single or related offense. <u>More...</u>

# SUICIDES UP FOR MIDDLE-AGE WHITES

More middle-age white people, women in particular, are taking their own lives, and mental-health workers can only speculate as to what might be driving the increase. Among whites ages 40 to 64, the suicide rate rose by 2.7 percent annually for men and 3.9 percent annually for women between 1999 and 2005, according to a new study led by a researcher at the Johns Hopkins Bloomberg School of Public Health in Baltimore. Those increases brought suicide rates per 100,000 white people to 26.9 for men and 8.2 for women in that age group. More...

# FREE MENTAL HEALTH TRAINING FOR JAIL AND COURT PERSONNEL

A core part of the National Alliance on Mental Illness of Ohio (NAMI Ohio) mission is to provide free training to dispel the myths about mental illness and to promote understanding. NAMI Ohio provides free one-day training for jail and court personnel who regularly encounter individuals with mental illness. Participants include parole, probation, corrections officers, public defenders, prosecutors, bailiffs, school personnel, and program coordinators who work with court involved youth. Attendees will learn to identify major mental illnesses and their typical characteristics; techniques to manage individuals with mental illness; how to better prevent crisis situations and how to handle them when they do occur; how to identify risk factors for suicide in correctional settings; about opportunities to expand court based jail diversion programs for individuals with mental illness. Attendees will also benefit from a presentation by an officer trained in Crisis Intervention Team training (a 40 hour academy providing de-escalation training for first responders). Ultimately, it is the goal of this training for participants to come away with a better understanding of what it might be like to have a mental illness. ### JUSTICE DEPARTMENT STUDY DISPELS MYTHS ABOUT GIRLS' DELINQUENCY

The Justice Department's Office of Justice Programs' (OJP) Office of Juvenile Justice and Delinquency Prevention (OJJDP) today released a research bulletin, "Charting the Way to Delinquency Prevention for Girls," which reports that despite the rise in female juvenile crime, violence among female youth has not increased.

Following a sharp increase in arrests among female juveniles in the 1990s, OJJDP convened the Girls Study Group (GSG) to gain a better understanding of girls' delinquency and guide policy toward female juvenile offenders. While the majority of delinquent offenders are boys, little research exists on female juvenile delinquency. This first bulletin, part of a forthcoming series, summarizes findings from a comprehensive research project into girls' delinquent behavior.

"The Office of Justice Programs created the Girls' Study Group to fully understand why an increasing number of girls are entering the juvenile justice system and to better understand how to prevent and intervene in girls' delinquency," said Jeffrey L. Sedgwick, Assistant Attorney General for OJP.

Key findings of the OJJDP-sponsored Girls Study Group include the following:

- Girls are not more violent now than in previous years. One of the factors discussed in the bulletin is the unintended impact of relatively new mandatory or pro-arrest policies put in place to protect victims of domestic violence.
- Girls and boys experience many of the same delinquency factors and that, while some risk factors are more gender-sensitive, focusing on general risk and protective factors for all youth is effective.
- Developing and using appropriate risk assessment tools for youth of both genders is crucial to ensuring the best response.
- A concerted effort is needed to address the lack of evidence-based programs for the juvenile justice field overall, as well as the lack of programming for girls specifically.

"By convening the Girls' Study Group, we made understanding girls involvement in delinquency a priority," said J. Robert Flores, Administrator of OJJDP. "We will use the data collected from this study to assist government and community leaders in responding to the needs of girls."

Over the next several months, a series of bulletins will be released highlighting the Girls Study Group findings, each one focusing on specific questions from the study group's research. The questions answered by the bulletins will include:

- Which girls become delinquent?
- What factors protect girls from delinquency?
- What factors put girls at risk for delinquency?
- What pathways lead to girls' delinquency?
- How should the juvenile justice system respond to girls' delinquency?
