#### CHILDREN RESCUED FROM PROSTITUTION TO GET SAFE HOUSE

A child rescued from sex trafficking is not yet a safe one. There are wounds to heal, particularly psychological ones, from weeks, months, or even years of daily rape and beatings. There also is the problem of violent and vengeful pimps who won't go quietly into the night. "They're interested really in that kid not getting to the witness stand," said Celia Williamson, a University of Toledo associate professor of social work and founder of Second Chance, a Toledo group that supports victims of sex trafficking. #### STATE PATROL: DRUG ARRESTS IN OHIO ON THE INCREASE

Drug arrests are up throughout Ohio and Butler County ranks among the highest, the Ohio Highway Patrol reported Tuesday, Dec. 2. During the first 10 months of 2008, the patrol said nearly 20 percent of its 4,453 drug arrests occurred in five counties: Stark, 179; Franklin, 175; Scioto, 169; Summit, 143; and Butler, 130. There were 117 such arrests in Montgomery, 59 in Warren, 55 in Miami and 42 in Greene. Drug arrests are up overall by about 13 percent, according to the patrol. Through October, troopers have made 505 arrests and seized nearly \$45 million in narcotics. More...

The OVW Transitional Housing Assistance Grants for Victims of Domestic Violence, Dating Violence, Stalking, or Sexual Assault Program (Transitional Housing Assistance Program) focuses on a holistic, victim-centered approach to provide transitional housing services that move individuals into permanent housing. Grants made under this grant program support programs that provide assistance to victims of domestic violence, dating violence, sexual assault, and stalking who are in need of transitional housing, short-term housing assistance, and related support services.

#### **CSAT TRAVEL AWARDS**

The Center for Substance Abuse Treatment (CSAT) will sponsor up to 30 Travel Awards for substance abuse treatment practitioners to attend the 2009 CPDD meeting. To be eligible, candidates must hold full-time employment as a director or clinical supervisor in a substance abuse treatment program and not be an employee of the federal government. Only one award will be given to any specific program. Previous CSAT travel award recipients are not eligible to apply. All expenses will be covered: i.e., conference registration, airfare, travel to and from the airport, and hotel accommodation. Applicants will be sent emails by the end of March indicating award status.

- 1. An up-to-date resume or vitae including contact information, previous travel fellowships, if applicable, work experience and academic experience. **Please include your current e-mail address**.

- 3. A letter of support on institutional letterhead from your direct supervisor stating should you be selected that you will be allowed to attend.

Complete, collated applications must be received on or before January 10, 2009. Late or incomplete applications will not be considered. The National Institute of Justice (NIJ) is the research, development, and evaluation agency of the U.S. Department of Justice (DOJ) and a component of the Office of Justice Programs (OJP). NIJ provides objective, independent, evidence-based knowledge and tools to enhance the administration of justice and public safety. NIJ solicits applications to inform its search for the knowledge and tools to guide policy and practice. NIJ is seeking proposals for research to evaluate the effectiveness of a demonstration program that includes a drug-testing, sanctions, and treatment protocol for chronic drug users under criminal justice supervision in the community. The basic principles of the program must include: (1) frequent drug testing; (2) certain, swift, and proportionate sanctions for failed tests; and (3) access to residential treatment, as appropriate. The purpose of this research is to inform and improve criminal justice and public health policy and practice and to reduce recidivism among chronic drug offenders on pretrial status, probation, or parole.

#### FREE MENTAL HEALTH TRAINING FOR JAIL AND COURT PERSONNEL

A core part of the National Alliance on Mental Illness of Ohio (NAMI Ohio) mission is to provide free training to dispel the myths about mental illness and to promote understanding. NAMI Ohio provides free one-day training for jail and court personnel who regularly encounter individuals with mental illness. Participants include parole, probation, corrections officers, public defenders, prosecutors, bailiffs, school personnel, and program coordinators who work with court involved youth. Attendees will learn to identify major mental illnesses and their typical characteristics; techniques to manage individuals with mental illness; how to better prevent crisis situations and how to handle them when they do occur; how to identify risk factors for suicide in correctional settings; about opportunities to expand court based jail diversion programs for individuals with mental illness. Attendees will also benefit from a presentation by an officer trained in Crisis Intervention Team training (a 40 hour academy providing de-escalation training for first responders). Ultimately, it is the goal of this training for participants to come away with a better understanding of what it might be like to have a mental illness. #### NIJ: REDUCING THE DEMAND FOR PROSTITUTES

There is a "school" in San Francisco that can reduce re-arrests related to prostitution. The San Francisco District Attorney's office screens men who are arrested for soliciting prostitutes to see if they are eligible to attend the program. Those who qualify can choose between facing prosecution or paying a fee to attend a one-day class (known generically as the "john's school.") The program is a partnership of San Francisco's district attorney's office, police department, public health department and several local organizations—especially Standing Against Global Exploitation. An evaluation of the program shows that men who attend say they change their attitudes and behavior. The evaluation also shows the program can be replicated.
