Our tentative agenda has Dr. Chrisanne Gordon issuing the "challenge" by laying out the medical issues that result in criminal justice entanglement. TRAUMA-INFORMED CHILD WELFARE: A TWO PART WEBINAR SERIES:

November 15, 2012: Building Systems to Support Trauma-Informed Practice: This session will begin with an introduction to trauma informed child welfare systems, emphasizing how the pieces of a system can fit together to improve outcomes. Presenters will highlight resources available from the National Child Traumatic Stress Network (NCTSN), and local leaders from three systems - child welfare, mental health and courts - will discuss the steps they have taken to expand trauma-informed services both within their systems and in collaboration with other systems.

NAVIGATING CHANGES IN OHIO FOR EFFECTIVE ADVOCACY FOR YOUTH: JUVENILE RULE 3 AND SENATE BILL 337

Date: November 20, 2012

Recently, there have been two major changes that impact representation and advocacy of youth in delinquency and bindover cases. First, the Ohio Supreme Court adopted a new rule of procedure, Juvenile Rule 3, which changes access to counsel, including new provisions requiring consultations or court advisement on the dangers of self-representation. Second, on September 28, 2012, the provisions of Ohio Senate Bill 337 (SB 337) went into effect. This bill was designed to reduce collateral consequences for individuals involved in the justice system and included several youth-specific provisions around background checks, detention credit, juvenile record sealing and expungement, and the placement of youth in adult jails. This webcast is designed for all Ohio attorneys who represent youth in the juvenile and adult court. Faculty will provide an overview of Juvenile Rule 3 and SB 337. Significant time will be allocated to discussing the intent of the provisions, implementation of these provisions to date, relevant case law for consideration, implications for practice, and responding to questions from participants. PUBLICATION OFFERS BEST PRACTICES FOR SERVING VICTIMIZED AND TRAUMATIZED CHILDREN

The <u>Safe Start Center</u> has released "Victimization and Trauma Experienced by Children and Youth: Implications for Legal Advocates," a 16-page brief that examines the prevalence and impact of child victimization and exposure to violence. The <u>publication</u> also covers trauma-related stress symptoms, assessments, and treatments; offers practice tips for judges, attorneys, and court-appointed special advocates; and provides guidance for advancing policy to support trauma-informed practice.

NIDA LAUNCHES NEW TOOL FOR PARENTS: FAMILY CHECKUP: POSITIVE PARENTING PREVENTS DRUG ABUSE

As part of National Substance Abuse Prevention Month, the National Institute on Drug Abuse (NIDA) has launched Family Checkup, an online resource that equips parents with research-based skills to help keep their children drug-free. NIDA-funded research has shown the critical role parents play in preventing their children from using drugs. Family Checkup poses questions for parents to consider as they interact with their children; highlighting parenting skills that are important in preventing the initiation and progression of drug use among youth. The resource incorporates video examples that

The Meridians for Incarcerated Women: Participant Workbook assignments and presentations facilitate group participant healing and introspection. The Participant Workbook begins with an emphasis on deconstructing power and control dynamics and concludes with women identifying previously unrecognized resources, skills, and social supports. The Meridians for Incarcerated Women: Facilitator Manual guides group facilitators through each assignment and presentation's purpose, implementation, and key facilitation points.
