In this webinar, Gail Pendleton of ASISTA Immigration Assistance will describe how the U-Visa works and the role that FJC staff can play in ensuring it is a useful tool for law enforcement and a safe route to status for noncitizens. ASISTA provides technical assistance and training for Office on Violence Against Women grantees, serves as the primary liaison with the Department of Homeland Security on U-Visas and helped work with Congress to create the U-Visa in 2000.

This program builds the capacity of states, state and local courts, units of local government, and federally recognized tribal governments to either implement new drug courts or enhance pre-existing drug courts for individuals with substance abuse disorders or substance use and co-occurring mental health disorders, including histories of trauma, who are involved with the family dependency court as a result of child abuse, neglect, and other parenting issues. Applications are due by 11:59 p.m. E.T., on March 25, 2013. ****NEW**YOUTH AND DOMESTIC VIOLENCE NONPROFIT GRANTS**
