### LEGISLATIVE UPDATES

### SCHEDULES OF CONTROLLED SUBSTANCES: RESCHEDULING OF HYDROCODONE COMBINATION PRODUCTS FROM SCHEDULE III TO SCHEDULE II

Effective Date: October 6, 2014

With the issuance of this final rule, the Administrator of the Drug Enforcement Administration reschedules hydrocodone combination products from schedule III to schedule II of the Controlled Substances Act. This scheduling action is pursuant to the Controlled Substances Act which requires that such actions be made on the record after opportunity for a hearing through formal rulemaking. This action imposes the regulatory controls and administrative, civil, and criminal sanctions applicable to schedule II controlled substances on persons who handle (manufacture, distribute, dispense, import, export, engage in research, conduct instructional activities with, conduct chemical analysis with, or possess) or propose to handle hydrocodone combination products. ### PRETRIAL DETENTION AND RISK ASSESSMENT: THE NEWEST FINDINGS FROM THE FIELD

Learn about results from a recent national study done by The Arnold Foundation on the effects of pretrial detention. Driven by these results, the Arnold Foundation employed leading pretrial risk researchers to develop a pretrial risk instrument that determines risk for Failure to Appear and rearrest while on bond. Kentucky's statewide pretrial services program served as a test site for this new risk instrument and Director Tara Boh Klute will describe Kentucky's implementation of the new instrument and the 6 month follow up results. The day will conclude with a discussion of how these findings relate to Ohio. Ms. Starr of the Ohio Department of Rehabilitation and Correction will report on the current status of the Ohio Risk Assessment System Pretrial Assessment Tool (ORAS-PAT).
