MOTION AND PROCEDURAL RULINGS

2006-0690. Toledo v. Tellings.

Lucas App. No. L-04-1224, 2006-Ohio-975. This cause is pending before the court as an appeal from the Court of Appeals for Lucas County. Upon consideration of the joint motion to allow amicus curiae, Ohio Attorney General, Marc Dann, to participate in oral argument scheduled for April 4, 2007, in support of the appellant,

It is ordered by the court that the motion is granted, and amicus curiae shall share the time allotted to appellant.

DISCIPLINARY CASES

2001-0370. Cleveland Bar Assn. v. Young.

On July 18, 2001, this court permanently disbarred respondent, Leonard Young, Attorney Registration No. 0023715, last known address in Cleveland Heights, Ohio, from the practice of law pursuant to Gov.Bar R. V(6)(B)(1).

On November 27, 2006, relator, Cleveland Bar Association, filed with this court a motion for an order to appear and show cause why respondent, Leonard Young, should not be held in contempt for failing to obey this court's July 18, 2001, order of disbarment.

On January 18, 2007, this court ordered respondent to appear in person before this court on February 28, 2007. Respondent did not appear before the court on the scheduled date.

On March 6, 2007, this court granted relator's motion for contempt and found Leonard Young in contempt. The court ordered respondent to: (1) return to Carolyn Bridges-Graves all documents she provided to respondent; (2) return the retainer of \$300 paid by Ms. Bridges-Graves; and (3) reimburse the Clients'

Security Fund in the amount of \$27,892.61, plus interest, for awards made against him. The court further ordered respondent to file proof of such compliance within ten days of the date of the order. If respondent failed to file such proof, a warrant for respondent's arrest would be issued and respondent would be ordered to serve 30 days in jail.

On March 19, 2007, respondent filed a notice of proof of compliance and motion for stay of issuance of warrant for arrest. Respondent asserts that he has returned the \$300 retainer and all documents to Ms. Bridges-Graves, and he requests additional time to reach an agreement for repaying the Client's Security Fund. Upon consideration thereof,

It is ordered by the court that the issuance of the arrest warrant is stayed for a period of ten days from the date of this order. Within ten days of the date of this order, respondent shall enter into an agreement with the Client's Security Fund for repayment of the full amount, plus interest, of all awards made against respondent. Respondent shall file an executed copy of that agreement with the court within ten days of the date of this order. If respondent fails to file a copy of the executed repayment agreement with the court, an arrest warrant will be issued and respondent will be ordered to serve 30 days in jail.

It is further ordered, sua sponte, that all documents filed with this court in this case shall meet the filing requirements set forth in the Rules of Practice of the Supreme Court of Ohio, including requirements as to form, number, and timeliness of filings.

It is further ordered, sua sponte, that service shall be deemed made on respondent by sending this order, and all other orders in this case, by certified mail to the most recent address respondent has given to the Attorney Registration Section.

2006-1375. Trumbull County Bar Assn. v. Gray.

On August 21, 2006, this court suspended respondent, James E. Gray, under an interim remedial suspension. On March 2, 2007, respondent filed a motion to dissolve the August 21, 2006, order. Relator filed a memorandum opposing the motion. Upon consideration thereof,

It is ordered by this court that the motion is denied.

2006-2068. In re Resignation of Kovacs.

On affidavit of resignation from the practice of law of George C. Kovacs, Attorney Registration No. 0024070, and on report filed under seal by Disciplinary Counsel. Resignation accepted with disciplinary action pending.

2006-2243. In re Resignation of Barton.

On affidavit of resignation from the practice of law of Roland Neal Barton, Attorney Registration No. 0042775, and on report filed under seal by Disciplinary Counsel. Resignation accepted.

2007-0309. In re Weisberg.

On February 15, 2007, and pursuant to Gov.Bar R. V(5)(A)(3), the Secretary of the Board of Commissioners on Grievances and Discipline of the Supreme Court of Ohio certified to the Supreme Court a certified copy of a judgment entry of a felony conviction against Joseph D. Weisberg, an attorney licensed to practice law in the state of Ohio.

Upon consideration thereof and pursuant to Gov.Bar R. V(5)(A)(4), it is ordered and decreed that Joseph D. Weisberg, Attorney Registration No. 0001441, last known business address in Toledo, Ohio, is suspended from the practice of law for an interim period, effective as of the date of this entry.

It is further ordered that this matter is referred to the Disciplinary Counsel for investigation and commencement of disciplinary proceedings.

It is further ordered that respondent immediately cease and desist from the practice of law in any form and is forbidden to appear on behalf of another before any court, judge, commission, board, administrative agency or other public authority.

It is further ordered that, effective immediately, respondent is forbidden to counsel or advise or prepare legal instruments for others or in any manner perform legal services for others.

It is further ordered that respondent is divested of each, any and all of the rights, privileges and prerogatives customarily accorded to a member in good standing of the legal profession of Ohio.

It is further ordered that pursuant to Gov.Bar R. X(3)(G), respondent shall complete one credit hour of continuing legal education for each month, or portion of a month of the suspension. As part of the total credit hours of continuing legal education required by Gov.Bar R. X Sec(3)(G), respondent shall complete one credit hour of instruction related to professional conduct required by Gov.Bar R. X(3)(A)(1) for each six months, or portion of six months, of the suspension.

It is further ordered that respondent shall not be reinstated to the practice of law in Ohio until (1) respondent complies with the requirements for reinstatement set forth in the Supreme Court Rules for the Government of the Bar of Ohio; (2) respondent complies with this and all other orders issued by this court; (3) respondent complies with the Supreme Court Rules for the Government of the Bar of Ohio; and (4) this court orders respondent reinstated.

It is further ordered, sua sponte, by the court that within 90 days of the date of this order, respondent shall reimburse any amounts that have been awarded by

the Clients' Security Fund pursuant to Gov.Bar R. VIII(7)(F). It is further ordered, sua sponte, by the court that if, after the date of this order, the Clients' Security Fund awards any amount against the respondent pursuant to Gov.Bar R. VIII(7)(F), the respondent shall reimburse that amount to the Clients' Security Fund within 90 days of the notice of such award.

It is further ordered that on or before 30 days from the date of this order, respondent shall:

1. Notify all clients being represented in pending matters and any co-counsel of respondent's suspension and consequent disqualification to act as an attorney after the effective date of this order and, in the absence of co-counsel, also notify the clients to seek legal service elsewhere, calling attention to any urgency in seeking the substitution of another attorney in respondent's place;
2. Regardless of any fees or expenses due respondent, deliver to all clients being represented in pending matters any papers or other property pertaining to the client, or notify the clients or co-counsel, if any, of a suitable time and place where the papers or other property may be obtained, calling attention to any urgency for obtaining such papers or other property;
3. Refund any part of any fees or expenses paid in advance that are unearned or not paid, and account for any trust money or property in respondent's possession or control;
4. Notify opposing counsel in pending litigation or, in the absence of counsel, the adverse parties of respondent's disqualification to act as an attorney after the effective date of this order, and file a notice of disqualification of respondent with the court or agency before which the litigation is pending for inclusion in the respective file or files;
5. Send all such notices required by this order by certified mail with a return address where communications may thereafter be directed to respondent;
6. File with the Clerk of this court and the Disciplinary Counsel of the Supreme Court an affidavit showing compliance with this order, showing proof of service of notices required herein, and setting forth the address where the affiant may receive communications; and
7. Retain and maintain a record of the various steps taken by respondent pursuant to this order.

It is further ordered that respondent shall keep the Clerk, the Toledo Bar Association, and the Disciplinary Counsel advised of any change of address where respondent may receive communications.

It is further ordered, sua sponte, that all documents filed with this court in this case shall meet the filing requirements set forth in the Rules of Practice of the

Supreme Court of Ohio, including requirements as to form, number, and timeliness of filings.

It is further ordered, sua sponte, that service shall be deemed made on respondent by sending this order, and all other orders in this case, by certified mail to the most recent address respondent has given to the Attorney Registration Section.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.

Gov.Bar R. VI(1)(B) requires all attorneys admitted to the practice of law in Ohio to file a Certificate of Registration within thirty days of the date of admission. Section 6(A) establishes that an attorney who fails to file the Certificate of Registration on or before the due date, but pays within ninety days of the deadline, shall be assessed a late fee. Section 6(B) provides that an attorney who fails to file a Certificate of Registration and pay the fees either timely or within the late registration period shall be notified of noncompliance and that if the attorney fails to file evidence of compliance with Gov.Bar R. VI or to come into compliance with this rule within the late registration period, the attorney will be suspended from the practice of law.

Respondent has not registered for the 2005/2007 attorney registration biennium within thirty days of the date of admission and has not filed evidence of compliance with Gov.Bar R. VI or come into compliance with this rule within the late registration period.

Upon consideration thereof and in accordance with Gov.Bar R. VI(6)(B), respondent is hereby suspended from the practice of law in Ohio, effective as of the date of this order.

IT IS FURTHER ORDERED that respondent immediately cease and desist from the practice of law in any form and is hereby forbidden to appear on behalf of another before any court, judge, commission, board, administrative agency or other public authority.

IT IS FURTHER ORDERED that, effective immediately, respondent be forbidden to counsel or advise or prepare legal instruments for others or in any manner perform legal services for others.

IT IS FURTHER ORDERED that respondent shall not practice law in Ohio, hold himself or herself out as authorized to practice law in Ohio, hold nonfederal judicial office in Ohio, occupy a nonfederal position in this state in which the attorney is called upon to give legal advice or counsel or to examine the law or pass upon the legal effect of any act, document, or law, be employed in the Ohio judicial system in a position required to be held by an attorney, or practice before any nonfederal court or agency in this state on behalf of any person except himself or herself.

IT IS FURTHER ORDERED that if respondent fails to comply with this order, respondent may be referred for investigation of the unauthorized practice of law under Gov.Bar R. VII(3).

IT IS FURTHER ORDERED that respondent is hereby divested of each, any and all rights, privileges and prerogatives customarily accorded to a member in good standing of the legal profession in Ohio.

IT IS FURTHER ORDERED that notwithstanding respondent's suspension under Gov.Bar R. VI, respondent shall comply with Gov.Bar R. X (Attorney Continuing Legal Education).

IT IS FURTHER ORDERED that respondent shall not be reinstated to the practice of law in Ohio until (1) respondent files a Certificate of Registration for the 2005/2007 attorney registration biennium and all other biennia for which respondent has not registered, (2) respondent pays all applicable registration fees, (3) respondent pays a \$200 reinstatement fee, (4) respondent files an Application for Reinstatement on a form provided by the Attorney Registration/CLE Section, (5) and the Attorney Registration/CLE Section reinstates respondent to the practice of law.

IT IS FURTHER ORDERED that respondent shall keep the Attorney Registration/CLE Section advised of any change of address where respondent may receive communications.

IT IS FURTHER ORDERED that service shall be deemed made on respondent by sending this order, and all other orders in this matter, by certified mail to the most recent address respondent has provided to the Attorney Registration/CLE Section.
