Notifying Law Enforcement Agencies of Mental Illness.

#### **(B) Completion of form**

A court shall complete "Form 95" upon issuance, modification, or termination of a court order doing any of the following:

24		(1) Ordering a person who pled guilty to or who was convicted of an offense
25		of violence to receive a mental health evaluation;

27		(2) Ordering a person who pled guilty to or who was convicted of an offense
28		of violence to receive treatment for mental illness;

30		(3) Approving a conditional release of a person who was found not guilty by
31		reason of insanity and the person was committed pursuant to R.C. 2945.40;

33		(4) Approving a conditional release of a person who was found incompetent
34		to stand trial with no substantial probability of becoming competent again even
35		with a course of treatment and the person was committed pursuant to R.C.
