This matter comes on for review on March 31<sup>st</sup>, 2020 of the Administrative Orders issued by this Court on March 13<sup>th</sup>, 2020, March 16<sup>th</sup>, 2020 and March 23<sup>rd</sup>, 2020. The Court finds a continued state of emergency exists due to the continued confirmed cases of Coronavirus (COVID-19) in Ohio and Nationwide. Due to the continued state of emergency, the Court finds it appropriate to continue these prior orders indefinitely.

**IT IS HEREBY ORDERED** that:

1. The orders set forth in the Court's Administrative Orders of March 13<sup>th</sup>, 2020, March 16<sup>th</sup>, 2020 and March 23<sup>rd</sup>, 2020 are continued indefinitely.
2. The Columbiana County Probate and Juvenile Divisions of the Court of Common Pleas shall remain open. The public may continue to utilize the court's services while following all applicable public health guidelines. Personal appearance at the courts shall be limited to those of strict necessity.
3. This Order will be reviewed as necessary, at which point the Court will amend, vacate or continue this Order.
4. The Deputy Clerk shall enter the judgment upon the Court's journal and within three (3) days thereafter shall serve upon all parties not in default for failure to appear notice of the judgment and its date of entry upon the journal.
