

On July 7, 2020, Governor Mike DeWine mandated protective face coverings be worn in public in all counties that are designated as a Red Alert Level 3 Public Health Emergency or a Purple Alert Level 4 Public Health Emergency.

On July 16, 2020, Licking County was declared a Red Alert Level 3 Public Health Emergency. As a result of this Public Health Emergency, and given that the Licking County Courthouse is a public building,

IT IS HEREBY ORDERED THAT ALL PERSONS ENTERING THIS BUILDING MUST WEAR A PROTECTIVE FACE COVERING.

No person shall be permitted to enter the building for any purpose unless or until that person has put on a protective face covering. Exceptions may be made on an individual basis for those with documented health issues which prevent wearing a protective face covering.

This order shall remain in effect until further order of this court.
