**JUDGMENT ENTRY DECLARING DEFENDANT KIMBERLY R. BEEM
A VEXATIOUS LITIGATOR**

Upon Motion of the Plaintiff, this Court's Memorandum of Decision dated February 20, 2019, and for good cause shown, it is hereby ORDERED that, pursuant to R.C. 2323.52, Defendant Kimberly R. Beem is declared to be a vexatious litigator, and consistent with that designation, Defendant Kimberly R. Beem is ORDERED indefinitely prohibited from doing any of the following without first obtaining leave of this Court to proceed:

- (A) Instituting legal proceedings in the Court of Claims or in a Court of Common Pleas, Municipal Court, or County Court;
- (B) Continuing any legal proceedings that she has instituted in any Ohio trial court prior to the entry of this Order;
- (C) Making any application, other than an application for leave to proceed under R.C. 2323.52(F)(1), in any legal proceedings instituted by her or another person in any of the Ohio trial courts listed above; or
- (D) Instituting or continuing any legal proceedings in the Court of Appeals without first obtaining leave from the Court of Appeals pursuant to R.C. 2323.52(F)(2).


