ENTRY

The Court held a hearing on November 19 and November 22, 2004 on plaintiff's motion to Declare James Triplett a vexatious litigator. Based on the evidence and arguments presented at the hearing and for the reasons stated at the conclusion of the hearing, the Court hereby finds that defendant James Triplett is a vexatious litigator under O.R.C. § 2323.52(A)(2)(a), (b), and (c) and is therefore prohibited, pursuant to O.R.C. § 2323.52(D)(1), from doing any of the following without first obtaining the leave of court: (a) instituting legal proceedings in the court of claims or in a court of common pleas court, municipal court, or county court; (b) continuing any legal proceedings that he has instituted in the court of claims, common pleas court, municipal court, or county court; and (c) making any application other than an application for leave to proceed under division (F)(1) of O.R.C. § 2323.52, that he has instituted in the court of claims, court of common pleas, municipal court, or county court. Defendant is also prohibited, pursuant to O.R.C. § 2323.52(D)(3), from instituting legal proceedings in a court of appeals, continue any legal proceedings that he had instituted in a court of appeals prior to this entry, or make any application, other than the application for leave to proceed allowed by division (F)(2) of O.R.C. § 2323.52, in any legal proceedings that he has instituted in a court of appeals without first




James Triplett is granted permission to file a Memorandum Contra Plaintiff's Motion for Summary Judgment on the creditor's bill.


