This matter originated in this court on the filing of a report by the Commission on Continuing Legal Education (the "commission") pursuant to Gov. Bar R. X(6)(A)(1)(b) and (A)(2)(d). The commission recommended the imposition of sanctions against certain attorneys, including the above-named respondent, for failure to comply with the provisions of Gov. Bar R. X, Attorney Continuing Legal Education, for the reporting period 1990-1991.

On June 18, 1993, this court entered an order adopting the commission's recommendation, suspending the respondent from the practice of law and imposing a fee sanction upon the respondent.

It has now come to the court's attention that the respondent is deceased. Upon consideration thereof,

IT IS ORDERED by the court that the order of June 18, 1993, pertaining to respondent, is hereby vacated and this cause is dismissed, effective July 28, 1993.
