If question of law number one is answered affirmatively, is the State of Ohio's requirement, under Ohio Revised Code § 3101.05(A), that both applicants for marriage licenses provide Social Security numbers as one of the grounds of eligibility to marry, unconstitutional as written or applied under the Due Process Clause of the Ohio Constitution, Article I, § 16?

{¶4} 3. If question of law number one is answered affirmatively and question of law number two negatively, is the State of Ohio's requirement, under Ohio Revised Code § 3101.05(A), that both applicants for marriage licenses provide Social Security numbers as one of the grounds of eligibility to marry, unconstitutional as written or applied under the Equal Protection Clause of the Ohio Constitution, Article I, § 2?"

 $\{\P5\}$ The court answers no to certified question No. 1.

 $\{\P6\}$ The court declines to answer certified questions Nos. 2 and 3 in view of its answer to certified question No. 1.
