At issue is which version applies—the version in effect at the time of the offense or the current version, effective prior to the institution of sentencing by the trial court—*when* application of the newer statute would change the offense from the offense indicted and to which the defendant

pled. Therefore, we find that a conflict of law exists. The motion to certify is granted.” (Emphasis sic.)
