DISCIPLINARY CASES

2002-1102. Disciplinary Counsel v. Connors.

On December 18, 2002, this court permanently disbarred respondent, John Joseph Connors Jr., Attorney Registration No. 0031717. On September 22, 2003, respondent filed a motion to correct the record based on newly discovered evidence. On October 2, 2003, relator filed a memo opposing the motion. On consideration thereof,

IT IS ORDERED by this court that the motion be, and hereby is, denied.

2002-1274. Disciplinary Counsel v. Mount.

On Application for Termination of Probation. Application granted.

2003-0732. In re Resignation of Spencer.

On July 15, 2003, this court accepted the resignation of respondent, Scott W. Spencer, Attorney Registration No. 0019945, with the designation of disciplinary action pending. On September 22, 2003, movant, Disciplinary Counsel, filed a motion for order to show cause why respondent should not be held in contempt for failing to obey this court's July 15, 2003 order. Upon consideration thereof,

IT IS ORDERED by this court that the motion be and is hereby granted to the extent that respondent show cause by filing a written response with the Clerk of this court on or before 20 days from the date of this order why respondent should not be held in contempt.

IT IS FURTHER ORDERED, sua sponte, that all documents filed with this court in this case shall meet the filing requirements set forth in the Rules of Practice of the Supreme Court of Ohio, including requirements as to form, number, and timeliness of filings.
