2004-0307. State ex rel. Holdren v. Indus. Comm.

Franklin App. No. 03AP-164, 2003-Ohio-7230. By entry dated May 24, 2004, this court dismissed this cause for want of prosecution for appellant's failure to file a merit brief. Insofar as appellant had previously obtained an extension of time to file his merit brief until June 16, 2004,
