MOTION AND PROCEDURAL RULINGS

2000-1030. Ohio Hosp. Assn. v. Armstrong World Industries, Inc.

Cuyahoga App. No. 76067. This cause is pending before the court as an appeal from the Court of Appeals for Cuyahoga County. On April 13, 2001, this court stayed further proceedings in this case and ordered appellee to file a notice with this court upon the termination of the automatic stay under the Bankruptcy Code.

IT IS ORDERED by the court, sua sponte, that appellee W.R. Grace & Son & Co.-Conn. file a notice advising this court of the status of the bankruptcy case within 15 days of the date of this entry.

2005-2162. Bellman v. Am. Internatl. Group.

Lucas App. No. L-03-1301, 163 Ohio App.3d 540, 2005-Ohio-5250. This cause is pending before the court as an appeal from the Court of Appeals for Lucas County. Upon consideration of appellant's motion for an extension of time to transmit the record,

IT IS ORDERED by the court that the motion is granted, and the time for transmitting the record is extended to March 28, 2006.

DISCIPLINARY CASES

1998-0713. Disciplinary Counsel v. Atkin.

On January 13, 1999, this court permanently disbarred respondent, Sanford I. Atkin. On February 16, 2006, respondent filed a motion to vacate and motion to proceed in forma pauperis. On consideration thereof,
