2006-1207. Pack v. Osborn.

Licking App. No. 05 CA 83, 2006-Ohio-2253. This cause is pending before the court as an appeal from the Court of Appeals for Licking County. Upon consideration of the joint motion to allow amicus curiae, Ohio Attorney General Marc Dann, to participate in oral argument scheduled for April 18, 2007, in support of the appellant,

It is ordered by the court that the motion is granted and amicus curiae shall share the time allotted to appellant.

2006-1212. Arbino v. Johnson & Johnson.

Certified Question of State Law, United States District Court for the Northern District of Ohio, Western Division, No. 3:06 CV 40010. This cause is pending before the court on the certification of a state law question from the United States District Court for the Northern District of Ohio, Western Division. Upon consideration of petitioner's motion to extend time for oral argument scheduled for May 1, 2007,
