MISCELLANEOUS DISMISSALS

2006-0778. State ex rel. Roddy v. Indus. Comm.

Franklin App. No. 04AP-930, 2006-Ohio-1185. This cause is pending before the court as an appeal from the Court of Appeals for Franklin County. Upon consideration of the joint application for dismissal,

It is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

2006-1121. State ex rel. Dist. 1199, Health Care & Social Serv. Union, SEIU v. Ohio Dept. of Job & Family Servs.

In Mandamus. This cause originated in this court on the filing of a complaint for a writ of mandamus. Upon consideration of relators' application for dismissal,

It is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

2007-0178. Wilson v. AC&S, Inc.

Butler App. No. CA2006-03-056, 2006-Ohio-6704. This cause is pending before the court as a discretionary appeal and claimed appeal of right. Upon consideration of appellant's application for dismissal,

It is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

MISCELLANEOUS ORDERS

The Supreme Court of Ohio has issued orders imposing sanctions upon 249 attorneys and judges for noncompliance with the provisions of Gov.Bar R. X and Gov.Jud. R. IV. The text of the entry imposing the sanction is reproduced below.

ORDER
[Filed April 17, 2007]

This matter originated in this court on the filing of a report by the Commission on Continuing Legal Education (the "commission") pursuant to Gov.Bar R. X(6)(A)(1)(b) and (A)(2)(d). The commission recommended the imposition of sanctions against certain attorneys and judges, including the above-named respondent, for failure to comply with the applicable continuing legal education provisions of Gov.Bar R. X and Gov.Jud.R. IV for the 2004-2005 reporting period.

On December 29, 2006, pursuant to Gov.Bar R. X(6)(B)(1), this court issued to the respondent an order to show cause why the commission's recommendation should not be adopted and an order so entered against the respondent. Respondent filed no objections to the commission's recommendation and this cause was considered by the court. Upon consideration thereof,

IT IS ORDERED by the court that the recommendation of the commission is adopted and, within 30 days of the date of this order, respondent shall pay to the Commission on Continuing Legal Education, by certified check or money order, a sanction fee which is hereby imposed in the total amount of \$[sanction amount].

IT IS FURTHER ORDERED that the respondent shall not be deemed to be in good standing with the Supreme Court of Ohio if the respondent has not complied with this order but that this order shall not be considered a disciplinary order pursuant to Gov.Bar R. V or Gov.Bar R. X(6)(H).

IT IS FURTHER ORDERED that the commission shall notify the Clerk of the court when payment of the imposed sanction has been made by respondent.

IT IS FURTHER ORDERED by the court that the Clerk shall send this order by certified mail to the respondent at the address registered with the Attorney Registration Section under Gov.Bar R. VI; that if this order is returned as undeliverable or unclaimed, the Clerk shall resend it by regular mail; and that

service of this order in accordance with the foregoing shall be deemed effective service.

IT IS FURTHER ORDERED that payment of the sanction notwithstanding, respondent shall comply with the requirements imposed by Gov.Bar R. X for the 2004-2005 reporting period. See CLE Reg. 503.4.

2007-0615. Rhodes v. Hamilton Cty. Bd. of Revision.

Board of Tax Appeals, No. 2005-M-1098.
