## DISCIPLINARY CASES

### **2007-1454. Disciplinary Counsel v. Glover.**

On Certified Order of the Supreme Court of Delaware, Case No. 584, 2006. Valerie Jamella Glover, Attorney Registration No. 0037197, is permanently disbarred from the practice of law in Ohio.

## MISCELLANEOUS DISMISSALS

### **2007-1327. State v. Holbert.**

Cuyahoga App. No. 88016, 2007-Ohio-986. This cause is pending before the court as a discretionary appeal and claimed appeal of right. It appears from the records of the court that the appellant has not filed a memorandum in support of jurisdiction, due Friday, October 26, 2007, in compliance with the Rules of Practice of the Supreme Court and therefore has failed to prosecute this cause with the requisite diligence. Upon consideration thereof,

It is ordered by the court that this cause is dismissed sua sponte.

### **2007-1850. Carriero v. Cincinnati Ins. Co.**

Cuyahoga App. No. 89037, 2007-Ohio-4171. This cause is pending before the court as a discretionary appeal. On October 9, 2007, when this appeal was filed, a check in the amount of \$40.00 was submitted by counsel for appellant to satisfy the requirement of the docket fee imposed by R.C. 2503.17 and S.Ct.Prac.R. XV(1). This court has been informed by the Office of the Treasurer of the State of Ohio that the check was returned because of insufficient funds. Whereas R.C. 2503.17 and S.Ct.Prac.R. XV(1) require that the docket fee shall be paid before a notice of appeal is filed or a case is docketed,

It is ordered by the court, sua sponte, that this cause is dismissed.
