**1999-0404. Cleveland Bar Assn. v. Simakis.**

On application for reinstatement of George K. Simakis, Attorney Registration No, 00029084. Application granted and respondent reinstated to the practice of law in Ohio.

**2006-1197. Disciplinary Counsel v. Johnson.**

On June 20, 2008, respondent, Bryan Bright Johnson, Attorney Registration No. 0003981, last known business address in Columbus, Ohio, filed an application for termination of probation. Upon consideration thereof, the court finds that respondent has substantially complied with Gov.Bar R. V(9)(D) and with its order, dated December 19, 2007, in which the court reinstated respondent, stayed the final six months of his suspension, and placed him on probation for a period of six months with conditions.

Therefore, it is ordered by this court that the probation of respondent is terminated.

It is further ordered that the Clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.

E N T R Y

This matter originated in this court on the filing of a report by the Commission on Continuing Legal Education (“commission”) pursuant to Gov.Bar R. X(6)(A)(1)(b) and (A)(2)(d). The commission recommended the imposition of sanctions against certain attorneys, including the above-named respondent, for failure to comply with the provisions of Gov.Bar R. X, Attorney Continuing Legal Education, for the 1995-1996 reporting period.

On July 2, 1998, this court adopted the recommendation of the commission, imposed a sanction fee upon the respondent, and suspended the respondent from the practice of law pursuant to Gov.Bar R. X(6)(B)(3) and (5)(A)(4). The court further ordered that respondent shall not be reinstated to the practice of law in Ohio until respondent complies with the requirements for reinstatement set forth in Gov.Bar R. X(7), respondent complies with the Supreme Court Rules for the Government of the Bar of Ohio, respondent complies with this and all other orders of the court, and this court orders respondent reinstated.

On June 20, 2008, the commission filed a recommendation pursuant to Gov.Bar R. X(7)(B)(2), finding that the respondent has paid all fees assessed for noncompliance, has made up all deficiencies and is now in full compliance with all requirements of Gov.Bar R. X, and recommending that the respondent be reinstated to the practice of law in Ohio. The commission certified that respondent had completed the credit hours of continuing legal education required during the suspension by this court’s order of suspension. Respondent has satisfied all the requirements of this court’s order of suspension. Upon consideration thereof,

It is ordered by the court that the recommendation of the commission is adopted and respondent, George Konstantine Simakis, is hereby reinstated to the practice of law.
