# MOTION AND PROCEDURAL RULINGS

# 2008-0215. State v. Sanchez.

Greene App. No. 06-CA-154, 2007-Ohio-6697. This cause is pending before the court as an appeal from the Court of Appeals for Greene County. Upon consideration of the motion of amicus curiae, Ohio Public Defender, to order the state of Ohio to properly serve its notice of appeal and notice of certified conflict and to set a deadline for the Ohio Public Defender to file a brief,

It is ordered by the court that the motion is granted.

It is further ordered that the Ohio Public Defender may file an amicus brief in support of appellee within 30 days of the date of this entry.

#### 2008-0429. State v. Sanchez.

Greene App. No. 06-CA-154, 2007-Ohio-6697. This cause is pending before the court on the certification of a conflict by the Court of Appeals for Greene County. Upon consideration of the motion of amicus curiae, Ohio Public Defender, to order the state of Ohio to properly serve its notice of appeal and notice of certified conflict and to set a deadline for the Ohio Public Defender to file a brief,

It is ordered by the court that the motion is granted.

It is ordered by this court, sua sponte, that Michael Douglas Triplett, Attorney Registration No. 0040172, last known business address in Williamstown, Kentucky, is found in contempt for failure to comply with this court's order of February 7, 2008, to wit: failure to surrender his Certificate of Admission and failure to file an affidavit of compliance on or before March 10, 2008.
