MOTION AND PROCEDURAL RULINGS

2008-0128. Lima v. State.

Allen App. No. 1-07-21, 177 Ohio App.3d 744, 2007-Ohio-6419. This cause is pending before the court as an appeal from the Court of Appeals for Allen County. Upon consideration of the motion of amicus curiae, city of Cleveland, to participate in oral argument scheduled for January 20, 2009, in support of the appellee,

It is ordered by the court that the motion is granted, and the amicus curiae shall share the time allotted to appellee.

2008-0582. State v. Silverman.

Montgomery App. No. 22097, 176 Ohio App.3d 12, 2008-Ohio-618. This cause is pending before the court as an appeal from the Court of Appeals for Montgomery County. Upon consideration of the joint motion of appellee and amicus curiae Ohio Public Defender to participate in oral argument scheduled for February 3, 2009,
