## MOTION AND PROCEDURAL RULINGS

### **1986-1976. State v. Bedford.**

Hamilton App. No. C-840850. By entry filed February 8, 2011, this court ordered that Danny Lee Bedford's sentence be carried into execution on Tuesday, May 17, 2011.

In order to facilitate this court's timely consideration of any matters relating to the execution of Bedford's sentence, it is ordered by the court that the Chief Justice may suspend application of any provisions of the Rules of Practice of the Supreme Court, including, but not limited to, the filing requirements imposed by S.Ct.Prac.R. 14.1.

It is further ordered that service of documents as required by S.Ct.Prac.R. 14.2 shall be personal, by facsimile transmission, or by e-mail.

It is further ordered that counsel of record for the parties shall provide this court with a copy of any document relating to this matter that is filed in, or issued by, any other court in this state or any federal court, as well as any commutation, pardon, or warrant of reprieve issued by the Governor. A copy of the document shall be delivered to the Office of the Clerk as soon as possible, either personally, by facsimile transmission, or by e-mail.

## DISCIPLINARY CASES

### **2011-0043. Disciplinary Counsel v. Ferreri.**

This cause is before the court upon the filing of a Final Report by the Board of Commissioners on Grievances and Discipline of the Supreme Court of Ohio. The report recommends that the respondent, Robert Ferreri, Atty. Reg. No. 0000860, be indefinitely suspended from the practice of law in Ohio pursuant to Gov.Bar R. V(6)(B)(2).

By order dated April 14, 2011, this court accepted respondent's resignation from the practice of law as a resignation with disciplinary action pending in case No. 2011-0466, *In re Resignation of Ferreri*. Pursuant to the court's order and Gov.Bar R. V(11)(G), the resignation is unconditional, final and irrevocable.

It is ordered by the court that case No. 2011-0043, *Disciplinary Counsel v. Ferreri*, is dismissed as moot.

It is further ordered that respondent be taxed the costs of these proceedings in the amount of \$1,208.46, which costs shall be payable to this court by cashier's check or money order on or before 90 days from the date of this order. It is further ordered that if these costs are not paid in full on or before 90 days from the date of this order, interest at the rate of ten percent per annum shall accrue as of 90 days from the date of this order, respondent will be found in contempt of the Supreme Court, and the matter will be referred to the office of the Attorney General for collection.

It is further ordered, sua sponte, by the court, that within 90 days of the date of this order, respondent shall reimburse any amounts that have been awarded against the respondent by the Clients' Security Fund pursuant to Gov.Bar R. VIII(7)(F). It is further ordered, sua sponte, by the court that if, after the date of this order, the Clients' Security Fund awards any amount against the respondent pursuant to Gov.Bar R. VIII(7)(F), the respondent shall reimburse that amount to the Clients' Security Fund within 90 days of the notice of such award.

### **MISCELLANEOUS ORDERS**

On March 31, 2011, the Supreme Court of Ohio Commission on Continuing Legal Education issued orders imposing monetary sanctions and suspension from the practice of law against three attorneys for noncompliance with the provisions of Gov. Bar R. X.

The following attorney was sanctioned and suspended from the practice of law for not completing the requisite hours required by Gov.Bar R. X(3)(C)(2)(a), not filing the final reporting transcript on or before January 31, 2010 as required by Gov.Bar R. X(3)(C)(2)(b), and not filing evidence of compliance or coming into compliance as required by Gov.Bar R. X(6)(B).
