## MOTION AND PROCEDURAL RULINGS

**2011-0019. Jackson v. Bartec, Inc.**

Franklin App. No. 10AP-173, 2010-Ohio-5558. This cause is pending before the court as an appeal from the Franklin County Court of Appeals.

Upon consideration of appellants' motion to extend the time for oral argument scheduled for October 19, 2011, it is ordered by the court that the motion is denied.

### **APPEALS ACCEPTED FOR REVIEW**

#### **2011-0990. State v. Simons.**

Champaign App. No. 2010 CA 7. Upon consideration of the jurisdictional memoranda filed in this case, the court accepts the appeal.

It is ordered by the court, sua sponte, that this cause is held for the decision in Supreme Court Case No. 2011-0685, *State v. Davis*, and the briefing schedule is stayed.

#### **2011-1490. In re Resignation of Koch.**

On affidavit of resignation from the practice of law of Richard Dean Koch, Attorney Registration No. 0020775, and on report filed under seal by Disciplinary Counsel. Resignation accepted with disciplinary action pending.

### **MISCELLANEOUS DISMISSALS**

#### **2010-1874. State ex rel. Brammer v. Indus. Comm.**

Franklin App. No. 10AP-106, 2010-Ohio-4608. This cause is pending before the court as an appeal from the Franklin County Court of Appeals. Upon consideration of appellant's application for dismissal, it is ordered by the court that the application for dismissal is granted.

Accordingly, this cause is dismissed.

#### **2011-1031. State v. Sohrabi.**

Cuyahoga App. No. 95358, 2011-Ohio-1935. This cause is pending before the court as a discretionary appeal and claimed appeal of right. The records of this court indicate that appellant has not filed a memorandum in support of jurisdiction, due September 23, 2011, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that this cause is dismissed.

**2011-1433. Brammer v. Brammer.**

Marion App. No. 91049, 2011-Ohio-2610. This cause is pending before the court as a discretionary appeal. The records of this court indicate that appellant has not filed a memorandum in support of jurisdiction, due September 19, 2011, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that this cause is dismissed.
