**2011-0890. State ex rel. DeWine v. GMAC Mtge, L.L.C.**

Certified Question of State Law, United States District Court, Northern District of Ohio, Western Division, Case Nos. 3:10-cv-02537-JZ and 1:10-cv-02709-JZ. This cause is pending before the court on the certification of a state law question from the United States District Court for the Northern District of Ohio, Western Division.

Upon consideration of the motions for permission to appear pro hac vice of Victoria Holstein-Childress, Robyn C. Quattrone, and Benjamin B. Klubes, it is ordered by the court that the motions are granted.

**2011-1177. State, ex rel. ESPN, Inc. v. Ohio State Univ.**

Mandamus. This cause originated in this court on the filing of a complaint for a writ of mandamus.

Upon consideration of the motion for admission pro hac vice of Ada Meloy on behalf of the American Council on Education, it is ordered by the court that the motion is granted.

**2011-1882. State v. Roberts.**

Guernsey App. No. 10CA000047, 2011-Ohio-4969. This cause is pending before the court as a discretionary appeal and claimed appeal of right.

Upon consideration of the amended motion for permission to appear pro hac vice of Sharon Katz, it is ordered by the court that the motion is granted.

### **MISCELLANEOUS DISMISSALS**

**2010-1141. State ex rel. YRC, Inc. v. Hood.**

Franklin App. No. 09AP-529, 2010-Ohio-2190. This cause is pending before the court as an appeal from the Court of Appeals for Franklin County.
