2010-1283. State ex rel. Warner v. Indus. Comm., Slip Opinion No. 2012-Ohio-1084.

Franklin App. No. 09AP-841, 2010-Ohio-2476. Judgment affirmed in part and reversed in part.

O'Connor, C.J., and Pfeifer, Lundberg Stratton, O'Donnell, Lanzinger, Cupp, and McGee Brown, JJ., concur.

2011-0464. Disciplinary Counsel v. Summers, Slip Opinion No. 2012-Ohio-1144.

On Certified Report by the Board of Commissioners on Grievances and Discipline, No. 10-037. William Lawrence Summers, Attorney Registration No. 0013007, is suspended from the practice of law in Ohio for six months.

O'Connor, C.J., and Pfeifer, Lundberg Stratton, Lanzinger, Cupp, and McGee Brown, JJ., concur.

O'Donnell, J., dissents and would impose a six-month stayed suspension.

MOTION AND PROCEDURAL RULINGS

2011-1197. Bay Mech. & Elec. Corp. v. Levin.

Board of Tax Appeals, No. 2008-K-1687. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of appellant's motion for continuance of oral argument scheduled for Thursday, April 26, 2012, it is ordered by the court that the motion is granted, and oral argument is rescheduled for Thursday, May 31, 2012.

2011-1959. In re J.L.H.

Stark App. No. 2010CA00266, 2011-Ohio-5586. This cause is pending before the court as an appeal from the Court of Appeals for Stark County.

Upon consideration of appellants/cross-appellees' motion to strike the notice of cross-appeal and memorandum in response and in support of cross-appeal, it is ordered by the court that the motion is granted in part and appellants/cross-appellees shall file a memorandum in response within 30 days of the date of this entry.

2012-0216. State v. Willan.

Summit App. No. 24894, 2011-Ohio-6603. This cause is pending before the court as a discretionary appeal and claimed appeal of right.

Upon consideration of the motion for admission pro hac vice of Joseph Opron, it is ordered by the court that the motion is granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.

2012-0434. State ex rel. Koller v. Sutula.

Cuyahoga App. No. 97173, 2012-Ohio-369. This cause was filed as a discretionary appeal and claimed appeal of right. Upon consideration of appellant's jurisdictional memorandum, it is determined by the court that this cause originated in the court of appeals and, therefore, should proceed as an appeal of right pursuant to S.Ct.Prac.R. 2.1(A)(1).

It is ordered by the court that the clerk shall issue an order for the transmission of the record from the Court of Appeals for Cuyahoga County, and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 6.2 through 6.7.

2012-0462. Ford Motor Credit Co. v. Agrawal.

Cuyahoga App. No. 96413, 2011-Ohio-6474. This cause is pending before the court as a discretionary appeal and claimed appeal of right.

Upon consideration of the motion for admission pro hac vice of Jan T. Chilton, it is ordered by the court that the motion is granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.
