2011-0008 and 2011-0010. State v. Harris, Slip Opinion No. 2012-Ohio-1908.
Cuyahoga App. No. 95128, 190 Ohio App.3d 417, 2010-Ohio-5374. Judgment reversed and cause remanded.

2011-1323. In re Application of Gueli, Slip Opinion No. 2012-Ohio-1907.

On Report by the Board of Commissioners on Character and Fitness, No. 426. The pending application of Jeffrey Vincent Gueli to take the Ohio bar examination is disapproved, but he may apply for the July 2014 bar examination.

MOTION AND PROCEDURAL RULINGS

2011-1677. State v. Warner.

Cuyahoga App. No. 95750, 2011-Ohio-4096. This cause is pending before the court as an appeal from the Court of Appeals for Cuyahoga County.

Upon consideration of appellee's motion to file the supplement to appellee's merit brief under seal, it is ordered by the court that the motion is granted.

2011-2005. State v. Dean.

Clark C.P. No. 05-CR-348. This cause is pending before the court as a death-penalty appeal from the Court of Common Pleas of Clark County.

Upon consideration of appellant's motion for extension of time to transmit the record, it is ordered by the court that the motion is granted and the record shall be filed no later than June 29, 2012. No further motions for extension of time to file the record shall be granted.

2012-0350. Mickey v. Rokakis.

Cuyahoga App. No. 97053, 2012-Ohio-273. This cause is pending before the court as a discretionary appeal and claimed appeal of right.

Upon review of appellant's motion for reconsideration of this court's April 18, 2012 stay denial, it is ordered by the court that the motion is stricken as prohibited by S.Ct.Prac.R. 11.2(D).

DISCIPLINARY CASES

2008-1785. Disciplinary Counsel v. McCord.

This cause came on for further consideration upon the April 6, 2012 filing of petitioner's motion for leave to file a reply brief to relator's answer. On April 12, 2012, relator filed a memorandum in opposition to petitioner's motion.

Upon consideration thereof, the motion is granted. Petitioner may file a reply brief to relator's answer brief within 15 days of the date of this order.

MISCELLANEOUS DISMISSALS

2011-1927. State ex rel. Henderson v. Artistic Granite & Marble, L.L.C.

Franklin App. No. 10AP-715, 2011-Ohio-5052. This cause is pending before the court as an appeal from the Court of Appeals for Franklin County.

Upon consideration of appellant's application for dismissal, it is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

2012-0336. State ex rel. Ulery v. Capper.

Clark App. No. 2010-CA-97. This cause is pending before the court as an appeal from the Court of Appeals for Clark County. The records of this court indicate that appellant has not filed a merit brief, due May 1, 2012, in compliance with the

Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that this cause is dismissed.
