2011-1076. Houdek v. ThyssenKrupp Materials NA, Inc.

Cuyahoga App. No. 95399, 2011-Ohio-1694. This cause is pending before the court as a discretionary appeal and claimed appeal of right.

Upon consideration of amicus curiae Ohio Association for Justice's motion to participate in oral argument on Wednesday, June 20, 2012, it is ordered by the court that the motion is granted, and amicus curiae Ohio Association for Justice shall share the oral argument time allotted to appellee Bruce Houdek.

2011-1850. Girard v. Youngstown Belt Ry. Co.

Trumbull App. No. 2010-T-0079, 2011-Ohio-4699. This cause is pending before the court as an appeal from the court of appeals for Trumbull County.

Upon consideration of amicus curiae state of Ohio's motion to participate in oral argument on Tuesday, June 19, 2012, it is ordered by the court that the motion is granted. The state of Ohio shall be allotted five minutes of oral argument time and shall present argument after appellant's initial oral argument and before appellee's oral argument. Pursuant to S.Ct.Prac.R. 9.5(A)(2), appellant and appellee shall still be allotted 15 minutes each for oral argument.
