2011-1737. State v. Lampley.

Richland App. No. 10CA30, 2011-Ohio-3814. This cause is pending before the court as a discretionary appeal and claimed appeal of right.

On December 15, 2011, appellant presented a memorandum in support of jurisdiction that was rejected for failure to include a case number, and appearing to be untimely. Upon further review, the memorandum was timely presented for filing in this case. It is therefore ordered by the court that appellant's memorandum in support of jurisdiction is hereby deemed filed as of December 15, 2011. Appellee may file a memorandum in response within 30 days of the date of this entry.

DISCIPLINARY CASES

2009-1444. Disciplinary Counsel v. O'Malley.

This cause came on for further consideration upon the filing of an application for reinstatement by respondent, Patrick Joseph O'Malley, Attorney Registration No. 0058659, last known business address in North Royalton, Ohio.

The court coming now to consider its order of August 24, 2010, wherein the court, pursuant to Gov.Bar R. V(6)(B)(3), suspended respondent for a period of two years with credit for the interim felony suspension imposed in Case No. 2008-2078, finds that respondent has substantially complied with that order and with the provisions of Gov.Bar R. V(10)(A).

Therefore, it is ordered by this court that respondent is reinstated to the practice of law in the State of Ohio.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.
