## MERIT DECISIONS WITH OPINIONS

**2012-0667. Trumbull Cty. Bar Assn. v. Braun, Slip Opinion No. 2012-Ohio-5136.**

On Certified Report by the Board of Commissioners on Grievances and Discipline, No. 11-030. Gary Lee Braun, Attorney Registration No. 0021431, is indefinitely suspended from the practice of law in Ohio.

**2012-0672. Toledo Bar Assn. v. Royer, Slip Opinion No. 2012-Ohio-5147.**

On Certified Report by the Board of Commissioners on Grievances and Discipline, No. 11-057. George Ronald Royer, Attorney Registration No. 0031392, is suspended from the practice of law for one year, with the entire suspension stayed on conditions.

## MOTION AND PROCEDURAL RULINGS

**2011-1323. In re Application of Gueli.**

This cause came on for further consideration upon applicant's filing of a motion for clarification or modification. Upon consideration thereof, it is hereby ordered that applicant's motion is granted.

The applicant may submit a new application to register as a candidate for admission to the practice of law in Ohio no sooner than November 1, 2013, and may

apply to take the July 2014 bar examination if he (1) continues treatment with a qualified mental health professional and follows the recommended treatment, (2) enters into a new three-year OLAP contract, and (3) fully complies with all its terms and conditions as verified by OLAP.

## MISCELLANEOUS DISMISSALS

### **2012-0924. State ex rel. Lucas v. Indus. Comm.**

Franklin App. No. 11AP-93, 2012-Ohio-1843. This cause is pending before the court as an appeal from the Court of Appeals for Franklin County.

Upon consideration of the joint application for dismissal, it is ordered by the court that the joint application for dismissal is granted. Accordingly, this cause is dismissed.

**2012-1330. Dayton Bar Assn. v. Zugelder.** This cause is pending before the court upon the filing of a report and recommendation by the Board of Commissioners on Grievances and Discipline. On October 29, 2012, relator, Dayton Bar Association, filed a suggestion of death of respondent and a notice of dismissal.

Upon consideration thereof, it is ordered by the court that this matter is dismissed.

### **2012-1397. State ex rel. Rosebrough v. Warden, Marion Corr. Inst.**

Marion App. No. 9-12-30. This cause is pending before the court as an appeal from the Court of Appeals for Marion County. The records of this court indicate that appellant has not filed a merit brief, due October 23, 2012, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that this cause is dismissed.

### **2012-1427. State ex rel. Muhammad v. Franklin Cty. Court of Common Pleas.**

Franklin App. No. 11AP-296. This cause is pending before the court as an appeal from the Court of Appeals for Franklin County. The records of this court indicate that appellant has not filed a merit brief, due November 2, 2012, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that this cause is dismissed.
