#### MOTION AND PROCEDURAL RULINGS

### 2014-1231. Hicks v. Cadle Co.

Trumbull App. No. 2013-T-0017, 2014-Ohio-872. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of the motion for admission pro hac vice of F. Dean Armstrong, it is ordered by the court that the motion is granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.

#### **DISCIPLINARY CASES**

# 2010-0851. Disciplinary Counsel v. Pullins.

On petition for reinstatement of Scott Pullins, Attorney Registration No. 0076809. Petition granted, and respondent is reinstated to the practice of law in Ohio.

## 2013-0999. Disciplinary Counsel v. Deters.

This cause came on for further consideration upon the filing by respondent of a motion to seal filing of confidential information.

Upon consideration thereof, it is ordered by the court that respondent's motion to seal filing of confidential information is granted.

# 2013-0999. Disciplinary Counsel v. Deters.

This cause came on for further consideration upon the filing of a motion for reinstatement by respondent, Eric Charles Deters, Attorney Registration No. 0038050, last known business address in Independence, Kentucky.

The court, coming now to consider its order of January 27, 2014, wherein the court, pursuant to Gov.Bar R. V(11)(F)(4), suspended respondent for a period of 60 days and ordered that respondent will not be reinstated to the practice of law in Ohio until he is reinstated to the practice of law in the state of Kentucky, finds that respondent has not substantially complied with that order and with the provisions of Gov.Bar R. V(10)(A).

Therefore, it is ordered by this court that respondent's motion for reinstatement is denied.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.

#### 2013-1743. Cincinnati Bar Assn. v. Seibel.

On certification of default. Ronald Eugene Seibel, Attorney Registration No. 0077296, is indefinitely suspended from the practice of law.

## 2013-1944. Disciplinary Counsel v. Marsteller.

On certification of default. Derek Wayne Marsteller, Attorney Registration No. 0069340, is indefinitely suspended from the practice of law.

## 2014-0967. Disciplinary Counsel v. Seabury.

This matter is pending before the court upon the filing by the Board of Commissioners on Grievances and Discipline of its final report on June 9, 2014, recommending that respondent, Jason Daniel Seabury, be suspended for a term. On August 7, 2014, respondent's application for resignation was filed with the court.

On consideration thereof, this court has accepted respondent's resignation with disciplinary action pending, and it is ordered by the court that this case is dismissed as moot.

# 2014-0971. Stark Cty. Bar Assn. v. Marinelli.

This cause is pending before the court upon the filing of a report by the Board of Commissioners on Grievances and Discipline. Upon consideration thereof, it is ordered by the court, sua sponte, that this matter is remanded to the board to determine the amount of restitution currently owed to respondent's former clients.

Proceedings before this court in this case are stayed until further order of this court.
