MOTION AND PROCEDURAL RULINGS

2013-0281. Cox v. Cuyahoga Cty. Bd. of Revision.

Board of Tax Appeals, No. 2011-L-4495. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the joint motion to remand to the Cuyahoga County Board of Revision to implement a settlement agreement, it is ordered by the court that the cause is remanded to the Cuyahoga County Board of Revision to take further action as appropriate.

It is further ordered that mandates be sent to and filed with the Board of Tax Appeals and the Cuyahoga County Board of Revision.

2013-1644. Hulsmeyer v. Hospice of Southwest Ohio, Inc.

Hamilton App. No. C-120822, 2013-Ohio-4147. This cause is pending before the court as an appeal from the Court of Appeals for Hamilton County.

Upon consideration of the motion by appellants/cross-appellees, Hospice of Southwest Ohio, Inc. and Joseph Killian, to schedule oral argument to begin first on September 23, 2014, it is ordered by the court that the motion is granted.

2013-1766. Hulsmeyer v. Hospice of Southwest Ohio, Inc.

Hamilton App. No. C-120822, 2013-Ohio-4147. This cause is pending before the court as an appeal from the Court of Appeals for Hamilton County.

Upon consideration of the motion by appellants/cross-appellees, Hospice of Southwest Ohio, Inc. and Joseph Killian, to schedule oral argument to begin first on September 23, 2014, it is ordered by the court that the motion is granted.

2014-0740. Dublin City Schools Bd. of Edn. v. Franklin Cty. Bd. of Revision. Board of Tax Appeals, No. 2013-520. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the joint motion to remand the appeal to the Franklin County Board of Revision to implement a settlement agreement, it is ordered by the court that the cause is remanded to the Franklin County Board of Revision to take further action as appropriate.

It is further ordered that mandates be sent to and filed with the Board of Tax Appeals and the Franklin County Board of Revision.

2014-1489. HSBC Bank, USA v. Maust.

Fairfield App. No. 13 CA 82, 2014-Ohio-3170. This cause is pending before the court as an appeal from the Court of Appeals for Fairfield County.

Upon consideration of appellants' motion to stay the sheriff's sale set for September 12, 2014, and any subsequent foreclosure proceedings and/or collection activity pending the outcome of the instant matter, it is ordered by the court that the motion is denied.

DISCIPLINARY CASES

1996-1993. Lorain Cty. Bar Assn. v. Rinderknecht.

On August 4, 2014, respondent, Edward G. Rinderknecht, filed an application for termination of probation. Upon consideration thereof, the court finds that respondent has substantially complied with Gov.Bar R. V(9)(D) and with its order dated June 5, 2012, in which the court ordered respondent to serve a two-year period of monitored probation.

On consideration thereof, it is ordered by this court that the probation of respondent, Edward G. Rinderknecht, Attorney Registration No. 0025845, last known business address in Sheffield Lake, Ohio, is terminated.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(8)(D)(1), that publication be made as provided for in Gov.Bar R. V(8)(D)(2), and that respondent bear the costs of publication.

MISCELLANEOUS DISMISSALS

2014-1355. State ex rel. Hassen v. Maier.

Stark App. No. 2014CA00109, 2014-Ohio-3459. This cause is pending before the court as an appeal from the Court of Appeals for Stark County.

Upon consideration of appellant's application for dismissal, it is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

It is further ordered that a mandate be sent to and filed with the clerk of the Court of Appeals for Stark County.
