MOTION AND PROCEDURAL RULINGS

In re Bozsik.

On June 4, 2008, this court found Steven A. Bozsik to be a vexatious litigator under S.Ct.Prac.R. 4.03(B). This court further ordered that Bozsik was prohibited from continuing or instituting legal proceedings in the court without obtaining leave. On July 2, 2015, Bozsik presented a "motion for leave to commence proffered appeal of right."

It is ordered by the court that the motion for leave is denied.

In re Grundstein.

On June 3, 2009, this court found Robert Grundstein to be a vexatious litigator under S.Ct.Prac.R. 4.03. This court further ordered that Grundstein was prohibited from continuing or instituting legal proceedings in the court without obtaining leave. On July 14, 2015, Grundstein presented a motion for leave to proceed.

It is ordered by the court that the motion for leave is denied.

This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the joint motion to remand the appeal to the Board of Tax Appeals in order to implement a settlement, it is ordered by the court that the cause is remanded to the Board of Tax Appeals to take further action as appropriate. It is further ordered that a mandate be sent to and filed with the Board of Tax Appeals.
