MOTION AND PROCEDURAL RULINGS

2015-0937. Woodward Constr., Inc. v. For 1031 Summit Woods I, L.L.C.

Hamilton App. Nos. C-140145, C-140358 and C-140359, 2015-Ohio-975. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of the motions for admission pro hac vice of William G. Leonard and Natalie Mark and the second motion for admission pro hac vice of Henry M. Quillian III, it is ordered by the court that the motions are granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.

2015-1268. State ex rel. Davenport v. State.

Franklin App. No. 14AP-1041. This cause was filed as a jurisdictional appeal. Upon consideration of appellant's memorandum in support of jurisdiction, it is determined by the court that this cause originated in the court of appeals and, therefore, should proceed as an appeal of right pursuant to S.Ct.Prac.R. 5.01.

It is ordered by the court that the clerk shall issue an order for the transmission of the record from the Court of Appeals for Franklin County and the parties shall otherwise proceed in accordance with S.Ct.Prac.R. 16.02 through 16.07.

DISCIPLINARY CASES

2009-2284. Butler Cty. Bar Assn. v. Minamyer.

On July 13, 2015, respondent, William Eric Minamyer, filed an amended application for termination of probation. Upon consideration thereof, the court finds that respondent has substantially complied with Gov.Bar R. V(21)(D) and

with its order dated June 30, 2014, in which the court reinstated respondent to the practice of law and placed him on monitored probation for a period of one year.

On consideration thereof, it is ordered by this court that the probation of respondent, William Eric Minamyer, Attorney Registration No. 0015677, last known business address in Maineville, Ohio, is terminated.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(17)(D)(1) and that publication be made as provided for in Gov.Bar R. V(17)(D)(2).

2014-0544. Disciplinary Counsel v. Weithman.

On order to show cause. Stephen Edwin Weithman, Attorney Registration No. 0027094, is found in contempt for failure to comply with the court's February 12, 2015 order. The previously imposed stay of his two-year suspension is revoked, and he is suspended from the practice of law in Ohio.

MISCELLANEOUS DISMISSALS

2015-1020. Hawkins v. Darst.

In Mandamus. This cause originated in this court on the filing of a complaint for a writ of mandamus.

Upon consideration of relator's application for dismissal, it is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.
