This cause is pending before the court upon the filing of a certification of default by the Board of Professional Conduct. On May 14, 2015, this court imposed an interim default suspension upon respondent, Richard Lake Hiatt, pursuant to Gov.Bar R. V(14)(B)(1). On June 22, 2015, respondent filed a motion for leave to file an answer and request to terminate interim default suspension. On July 24, 2015, respondent filed a motion to expedite previously filed request to terminate interim default suspension. The motions were not opposed.

On consideration thereof, it is ordered that respondent's motion for leave to file an answer is granted. This matter is remanded to the board for further proceedings under Gov.Bar R. V(12). It is further ordered that respondent's motion to terminate interim default suspension is denied. The court further orders that the interim default suspension imposed against respondent on May 14, 2015, shall remain in place while this matter is pending before the board. It is further ordered that respondent's motion to expedite is denied.
