## MERIT DECISIONS WITH OPINIONS

**2011-2005. State v. Dean, Slip Opinion No. 2015-Ohio-4347.**

Clark App. No. 05 CR 0348. Judgment affirmed.

O'Connor, C.J., and Pfeifer, O'Donnell, Lanzinger, Kennedy, and French, JJ., concur.

O'Neill, J., concurs in part and dissents in part for the reasons set forth in his dissenting opinion in *State v. Wogenstahl*, 134 Ohio St.3d 1437, 2013-Ohio-164, 981 N.E.2d 900.

**2015-0279. Disciplinary Counsel v. Phillabaum, Slip Opinion No. 2015-Ohio-4346.**

On Certified Report by the Board of Professional Conduct, No. 2014-021. Jason Richard Phillabaum, Attorney Registration No. 0072219, is hereby suspended from the practice of law in Ohio for one year.
