## MOTION AND PROCEDURAL RULINGS

**2015-0381. Cleveland v. Jones.**

Cuyahoga App. No. 100598, 2015-Ohio-4201. This cause is pending before the court as an appeal from the Court of Appeals for Cuyahoga County.

Upon consideration of appellant's motion to supplement record, it is ordered by the court that the motion is granted. The clerk of the City of Cleveland Municipal Court shall transmit a copy of the initial-appearance orientation video to this court within ten days of the date of this entry.

**2015-1068. South-Western City Schools Bd. of Edn. v. Franklin Cty. Bd. of Revision.**

Board of Tax Appeals, No. 2014-2997. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the joint motion to remand the appeal to the Board of Tax Appeals in order to implement a settlement, it is ordered by the court that the cause is remanded to the Board of Tax Appeals to take further action as appropriate.
