## 2011-0379. Disciplinary Counsel v. Ranke.

On petition for reinstatement. Carolyn Kaye Ranke, Attorney Registration No. 0043735, is hereby reinstated to the practice of law in Ohio.

# 2015-0243. Akron Bar Assn. v. Bednarski.

The Board of Professional Conduct of the Supreme Court of Ohio filed a certification of default in the office of the clerk of this court on February 12, 2015. On March 13, 2015, this court imposed an interim default-judgment suspension upon respondent, Holly Lynn Bednarski, pursuant to Gov.Bar R. V(14)(B)(1). Respondent was ordered to show cause why the interim default-judgment suspension should not be converted into an indefinite suspension. Respondent filed second amended objections, and this cause was considered by the court.

On consideration thereof, it is ordered by this court that this matter is remanded to the board for the consideration of mitigation evidence only.

The court further orders that the interim default-judgment suspension imposed against respondent on March 13, 2015, shall remain in place while this matter is pending before the board. Proceedings before this court in this case are stayed until further order of this court.
