2014-1923. State ex rel. Conley v. Park, Slip Opinion No. 2015-Ohio-5226.

Stark App. No. 2014-CA-00169. Judgment reversed and cause remanded.

O'Connor, C.J., and O'Donnell, Lanzinger, Kennedy, French, and O'Neill, JJ., concur.

Pfeifer, J., dissents.

MOTION AND PROCEDURAL RULINGS

2014-1290. In re Comm. Rev. of Ohio Adm.Code Chapter 4901:1-10 regarding Elec. Cos.

Public Utilities Commission, No. 12-2050-EL-ORD. This cause is pending before the court as an appeal from the Public Utilities Commission of Ohio.

Upon consideration of the joint status report, it is ordered by the court that the stay of the briefing schedule is hereby extended. The parties shall notify the court within 60 days from the date of this entry of the status and whether the stay may be lifted.

2015-1672. State v. Dixon.

Montgomery App. No. 26753. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of appellant's "motion for verbal arguments and consolidation," it is ordered by the court that the motion is denied as moot.

2015-1735. State v. Dixon.

Montgomery App. No. 26676. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of appellant's "motion for verbal arguments and consolidation," it is ordered by the court that the motion is denied as moot.

DISCIPLINARY CASES

2015-0361. In re Resignation of Kaufman.

This matter came on for further consideration upon the filing by respondent of a motion to lift contempt.

Upon consideration thereof, it is ordered by the court that the motion is granted.

MISCELLANEOUS DISMISSALS

2014-2059. Lindardos v. Joe Tex, Inc.

Clermont App. No. CA2013-08-067, 2014-Ohio-4522. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of appellant's application for dismissal, it is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

2015-0687. Edgebrook, L.L.C. v. Testa.

Board of Tax Appeals, No. 2013-4795. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the application to dismiss cross-appeal, it is ordered by the court that the application for dismissal is granted. Accordingly, the cross-appeal and the case are dismissed.

2015-1810. State v. Owens.

Cuyahoga App. No. 102276, 2015-Ohio-3881. This cause is pending before the court as a jurisdictional appeal. The records of this court indicate that appellee/cross-appellant has not filed a memorandum in support of jurisdiction for his cross-appeal, due December 9, 2015, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that the cross-appeal is dismissed sua sponte. The jurisdictional appeal remains pending.

2015-1939. Chase Home Fin., L.L.C. v. Pfaffl.

Hamilton App. No. C-150483. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of appellants' application for dismissal, it is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.
