2014-1092. Clayton v. Ohio Bd. of Nursing, Slip Opinion No. 2016-Ohio-643.

2015-0175. Jefferson v. Bunting, Slip Opinion No. 2016-Ohio-614.

Marion App. No. 9-13-26. Judgment affirmed.

O'Connor, C.J., and Pfeifer, O'Donnell, Lanzinger, Kennedy, French, and O'Neill, JJ., concur.

2015-0541. In re Application of Scannell, Slip Opinion No. 2016-Ohio-583.

On Report by the Board of Commissioners on Character and Fitness, No. 556. John Richard Scannell's pending application for admission to take the Ohio bar examination is disapproved, but he may reapply in two years on conditions.

Pfeifer, O'Donnell, Lanzinger, Kennedy, French, and O'Neill, JJ., concur.

O'Connor, C.J., dissents and would not permit the applicant to reapply.

2015-0542. In re Application of Greenberg, Slip Opinion No. 2016-Ohio-613.

On Report by the Board of Commissioners on Character and Fitness, No. 594. Eric Warren Greenberg's pending application to register as a candidate for admission to the Ohio bar is disapproved, but he may reapply for admission to the practice of law.

MOTION AND PROCEDURAL RULINGS

2014-1035. State v. Wilks.

Mahoning C.P. No. 13 CR 540. This cause is pending before the court as a death-penalty appeal from the Court of Common Pleas of Mahoning County.

Upon consideration of appellee's motion to allow the state to review documents currently under seal, it is ordered by the court that the motion is granted. Counsel for appellee may come to the Supreme Court of Ohio clerk's office to review the sealed documents.

2015-0329. Southland Self Storage, L.L.C. v. Franklin Cty. Bd. of Revision.

Board of Tax Appeals, Nos. 2012-4183, 2012-4227, and 2012-4228. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the joint motion to remand the appeal to the Franklin County Board of Revision in order to implement a settlement, it is ordered by the court that the cause is remanded to the Franklin County Board of Revision to take further action as appropriate.

It is further ordered that mandates be sent to and filed with the Board of Tax Appeals and the Franklin County Board of Revision.

2016-0080. In re Complaint of Lycourt-Donovan v. Columbus Gas of Ohio, Inc.

Public Utilities Commission, Nos. 12-2877-GA-CSS, 13-124-GA-CSS, and 13-667-GA-CSS. This cause is pending before the court as an appeal from the Public Utilities Commission of Ohio.

Upon consideration of the motion for leave to intervene as appellee of Columbia Gas of Ohio, Inc., it is ordered by the court that the motion is granted.
