MOTION AND PROCEDURAL RULINGS

2016-1366. State ex rel. Boles v. Gorman.

In Mandamus. This cause came on for further consideration upon the filing of relator's motion for default judgment. It is ordered by the court that the motion is denied as moot.

2016-0257. Trumbull Cty. Bar Assn. v. Roland.

The records of this court indicate that appellant has not filed a memorandum in support of jurisdiction, due November 17, 2016, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence.

Upon consideration thereof, it is ordered by the court that this cause is dismissed.

It is further ordered that appellant's motion for stay of the court of appeals' judgment is denied as moot.
