## MOTION AND PROCEDURAL RULINGS

### **2015-2111. *Dulay v. Testa.***

Board of Tax Appeals, No. 2014-2074. On appellant/cross-appellee's motion for substitution of party. Motion granted.

Public Utilities Commission, No. 14-1297-EL-SSO. On motion of Ohio Edison Company, the Cleveland Electric Illuminating Company, and the Toledo Edison Company to consolidate this cause with No. 2017-1664. Motion granted. Briefing in Nos. 2017-1444 and 2017-1664 shall be consolidated. Appellants' brief shall be due February 5, 2018.
