2018-1384. State v. Hart.

Cuyahoga App. No. 105673, 2018-Ohio-3272. On appellee's motion for court-appointed counsel and permission to withdraw as counsel. Motion granted. The Ohio Public Defender's Office is appointed to represent appellee, and appellee shall file a memorandum in response to jurisdiction and an affidavit of indigence within 30 days.
