The parties are to brief the issue as stated on page 4 of the court of appeals' June 28, 2019 entry: "Does a trial court retain jurisdiction to determine if tolling based on absconding under R.C. 2929.15(A)(1) has occurred when community control revocation proceedings are

not initiated until after the specified community control term expires?" The conflict case is *State v. Meyer*, 9th Dist. Summit No. 26999, 2014-Ohio-3705.

Sua sponte, cause consolidated with 2019-1128, *State v. Rue*, and briefing in case Nos. 2019-0897 and 2019-1128 shall be consolidated. The parties shall file two originals of the briefs permitted under S.Ct.Prac.R. 16.02 through 16.04 and include both case numbers on the cover page of the briefs.
