### 2019-0407. State v. Jaeger.

Medina App. No. 17CA0072-M, 2018-Ohio-2994. On appellant's motion for leave of court, motion for enlargement of time to file motion for evidence, and motion for evidence. Motions denied.

#### 2019-1309. Lingle v. State.

Franklin App. Nos. 17AP-251 and 17AP-252, 2019-Ohio-2928. On review of order certifying a conflict. The court determines that a conflict exists. The parties are to brief the issue as stated on page 1 of the court of appeals' September 24, 2019 entry: "Does R.C. 2950.09(F) provide out-of-state offenders challenging their R.C. 2950.09(A) automatic sexual predator classification with a right to an evidentiary hearing whereby the offender must prove by clear and convincing evidence that he or she is not likely to commit a sexually-oriented offense in the future?" The conflict cases are *State v. Pasqua*, 157 Ohio App.3d 427, 2004-Ohio-2992 (1st Dist.), *State v. Forsythe*, 5th Dist. Stark No. 2012CA00225, 2013-Ohio-3301, and *State v. McMullen*, 8th Dist. Cuyahoga No. 97475, 2012-Ohio-2629.

The parties shall file two originals of the briefs permitted under S.Ct.Prac.R. 16.02 through 16.04 and include both case numbers on the cover page of the briefs. The parties shall otherwise comply with the requirements of S.Ct.Prac.R. 16.01 through 16.04.

## **RECONSIDERATION OF PRIOR DECISIONS**

#### 2017-0186. State v. Dunson.

Montgomery App. No. 26990, 2016-Ohio-8365. Reported at 156 Ohio St.3d 180, 2018-Ohio-5213, 124 N.E.3d 787. On motion for reconsideration. Motion granted. This court's December 27, 2018 decision reversing the judgment of the court of appeals on the authority of 2017-1579 and 2017-1609, *State v. Braden*, is vacated, and the appeal is reinstated and held for the decision in 2018-0797, *State v. Taylor*.

Kennedy and DeWine, JJ., dissent.

### 2019-0912. State v. Grevious.

Butler App. No. CA2018-05-093, 2019-Ohio-1932. Reported at 157 Ohio St.3d 1419, 2019-Ohio-3797, 131 N.E.3d 958. On motion for reconsideration. Motion granted. Discretionary appeal accepted on proposition of law No. I and cause held for the decision in 2019-1103, *State v. Kinney*.
